

Q2 profit beats estimates at ₹ 1,064 cr

Tech Mahindra reported a consolidated net profit of Rs 1,064 crore for the September quarter, a rise of 19 percent quarter on quarter from Rs 898 crore. The revenues rose 4 percent at Rs 8,630 crore against Rs 8,276 crore during the previous quarter. The Mahindra Group company reported dollar revenue of \$1,218.2 million. The results managed to beat Street estimates. Analysts polled by Reuters, on average, expected revenue of Rs 8,605.8 crore and profit of Rs 1,003.7 crore. The consolidated earnings before interest and taxes grew 23 percent to Rs 1,324.3 crore from Rs 1,076.1 crore reported during the June quarter. The EBIT margin rose to 15.3 percent a rise of over 2 percentage points from 13 percent quarter on quarter. The company reported an attrition rate of 20 percent, a rise from 19 percent during the previous quarter. It also said that it added 4 clients during the quarter, ending the reported period.

Tata Power Co As Mundra II eye resolution

Shares of Tata Power Co. Ltd and Adani Power Ltd rallied 13-18% on Monday after the Supreme Court directed the Central Electricity Regulatory Commission (CERC) to decide on relief for the imported coal-based plants run by these companies. The Gujarat government sought relief for these plants after the companies expressed their inability to run these plants because of heavy losses. As pointed out earlier in this column, much depends on the consent of other stakeholders (consumers and states apart from Gujarat) and the compensatory mechanism.

Still, the development is seen to have given a leg-up to the resolution process. So much so that investors gave little importance to the company's subdued financial

विवाहेतर संबंधों गोली मार हत्या का

नई दिल्ली, 30 अक्टूबर।

दिल्ली के बवाना क्षेत्र में सोमवार सुबह उस वक्त हड्डकप मच गया, जब एक महिला की सरेराह गोली मारकर हत्या कर दी गई। हत्या करने के बाद आरोपी मौके से फरार हो गए। घटना के बाद से क्षेत्र में सनसनी फैली हुई है। सूचना पाकर मौके पर पहुंची पुलिस ने शव को कब्जे में लेकर पोस्टमॉर्टम के लिए भेज दिया है। पुलिस के अनुसार शुरूआती जांच में पता चला है कि महिला टीचर की हत्या विवाहेतर संबंधों की बजह से हुई है।

पुलिस की जांच में मृतक शिक्षिका के परिजनों से पूछताछ से यह बात सामने आई है। पुलिस को मृतक की एक डायरी भी मिली है, जिसमें कुछ ऐसी बातें लिखी हैं। डायरी भी हत्या की इसी बजह की तरफ इशारा कर रही है। इसके बाद परिजनों से पूछताछ व जानकारी जुटाई जा रही है। साथ ही पुलिस

ने शिक्षिका के पति को हिरासत ले लिया है।

मामले को जाच कर रही पुलिस के अनुसार मृतक की पहचान टीचर सुनीता के रूप में हुई है। सुनीता सोनोपत के फिरेजुपु बांग स्थिर राजकीय उच्च विद्यालय में जेवी शिक्षिका थी। बताया जा रहा है कि वारदात को उस समय अंजाम दिया गया, जब वह सुबह रुक्कल जा रही थी। बल्फ्रैंड-ब्लॉयडेंड निक बंटी-बबली, युवाओं को थादिया लूतेह का फर्जी जॉब लेटर
